Contributors

James Desmond Anderson is dean of Program at the Cathedral College of the Laity in Washington, D.C., author of *To Come Alive*, and co-author of *The Management of Ministry*. He has been a consultant for various denominations, including work in Europe and South America, and served as the first president for the board of Alban Institute.

Don S. Browning is widely appreciated for his integrative approach to practical theology through many articles and such well-known books as *Generative Man* and *The Moral Context of Pastoral Care*. He is Alexander Campbell Professor of Religion and Psychological Studies of the Divinity School and dean of the Disciples Divinity House, University of Chicago.

Jackson W. Carroll, as director of the Center for Social and Religious Research of Hartford Seminary, has stimulated and written research on a wide range of critical issues facing the church, including his recent co-authored studies, Religion in America: 1950 to the Present, Too Many Pastors: The Clergy Job Market, and Women of the Cloth.

Carl S. Dudley is professor of Church and Community at Mc-Cormick Theological Seminary and director of the Midwest Center for Congregational Ministries. He has specialized in the study of congregations, including small churches, church growth, and churches in changing communities, and has published Making the Small Church Effective and Where Have All Our People Gone?

ALICE Frazer Evans is well known for her development of educational case studies from actual situations. She has published frequently through Harvard University's Intercollegiate Case Clearing House, contributed to many case study books, and co-authored Introduction to Christianity: A Case Method Approach and Casebook for Christian Living. She is executive director of the Association for Case Teaching.

H. Barry Evans is director of Program, College of Preachers, at Washington Cathedral. He coordinates a program on the Authority of the Church in Society, sponsored by the College in association with The Grubb Institute of Behavioural Studies, London, England. He is a frequent consultant for congregations, advisor to clergy in programs of study, and general editor of *Homiletic* magazine.

Robert A. Evans is founding president of the Association for Case Teaching and general editor for the Harper & Row series Experience and Reflection: Theological Casebooks. Dr. Evans is author of a dozen books, most recently Human Rights: A Dialogue Between The First and Third Worlds, and the executive director of Plowshares Institute, an agency for world peace and justice.

James F. Hopewell began his ministry as a missionary priest of the Episcopal Church in Liberia and then served for a decade as director of the Theological Education Fund for the World Council of Churches. Dr. Hopewell, who has specialized in world religions and cross-cultural communication, is professor of Religion and the Church, and director of the Rollins Center for Church Ministries, Candler School of Theology, Emory University.

JOSEPH C. HOUGH, JR. is dean of the faculty and professor of Christian Ethics at the School of Theology, Claremont, California. Author of *Black Power and White Protestants*, he is best known for his contributions to Christian ethics in the areas of racism, sexual oppression, world hunger, and ecology, and for his advocacy of reform in theological education.

H. Newton Malony is professor of Psychology in the Graduate School of Psychology of Fuller Theological Seminary. Dr. Malony is also director of the Programs of Integration in Psychology and Theology, and director of the Church Consultation Service. He has published numerous articles and books, including *Understanding Your Faith* and *Living the Answers*.

WILLIAM McKinney is secretary for research and evaluation with the United Church Board for Homeland Ministries in New York and president-elect of the Religious Research Association. He is co-author of two forthcoming books: *The Varieties of Religious Presence* (with Jackson W. Carroll and David A. Roozen) and a reconsideration of the social sources of American denominationalism (with Wade Clark Roof).

LOREN B. MEAD is founder and executive director of the Alban Institute in Washington, D.C. Formerly a pastor and teacher and director of Project Test Pattern, he is author of New Hope for Congregations. He is best known for creative research and consulting with clergy and congregations at the critical points of ministry and for his insightful column, "From Where I Sit," published regularly in Action Information.

David S. Pacini has served in various positions, from Harvard University tutor to assistant to the president of Colgate University to senior consulting psychologist in a detoxification center. Presently he is co-chairperson for the 1982–83 Emory University Symposium "Rethinking Human Rights" and assistant professor of Historical Theology, Candler School of Theology, Emory University.

Bruce Reed studied architecture and theology in Australia before moving to England after World War II. In 1957 he founded the Grubb Institute of Behavioural Studies for applied social science research with consulting relationships to industry, educational and penal institutions, social service agencies, and churches. He introduced the oscillation theory of religious experience with the publication of *The Dynamics of Religion* in 1978.

Wade Clark Roof, with the publication of Community and Commitment in 1974, demonstrated the relationship between particular community lifestyles and the patterns of growth in denominations with corresponding values. He is professor of Sociology, University of Massachusetts, Amherst, and associate editor of both Review of Religious Research and Social Forces.

Lyle E. Schaller, more than any other single individual, has shaped the field of church consulting during the past twenty years. Annually he works with about 150 congregations of twenty denominations in thirty states and still finds time to serve as re-

source person to workshops, pastors' schools, and training programs. He has authored more than four hundred articles and a score of books, most recently, *The Small Church Is Different* and *Growing Plans*.

Barbara G. Wheeler has specialized in continuing education for clergy and theological education for laity, with an emphasis on evaluation and program development. She has served as consultant in the Religion Division of the Lilly Endowment and evaluator for such places as the Harvard Divinity School and the National Institute for Campus Ministries. Ms. Wheeler is president of Auburn Theological Seminary in New York City.

MELVIN D. WILLIAMS is a cultural anthropologist who has applied ethnography to the study of religion in the study of a church, Community in a Black Pentecostal Church, and of a community, On the Street Where I Lived. As professor of Sociology and Anthropology and director of Africana Studies and Research Center, Purdue University, he is finishing a new book, Black Churches in West Middletown, U.S.A.

Preface

The importance of the local church is often overlooked in the public press. In their reporting on religion, the mass media seem preoccupied with the actions of extremists, trends reflected in the public opinion polls, and statements by leaders and national religious assemblies. But the majority of people in the United States and Canada have chosen to relate themselves to the Christian faith through local congregations. Their faith is not found in extreme behavior, opinion polls, or pronouncements about religion. They associate believing with the local church and community pastor, with weddings, funerals, and personal crises, with Sunday school and neighborhood church activities.

Church members support more than 330,000 local congregations, which are found in every segment of society. There are more churches than schools, more church members than people who belong to any other voluntary association, and more financial support for churches than for all other philanthropic causes combined. Dire predictions of an earlier decade to the contrary, congregations of believers have retained their strength in a changing world. Although the ministry of the church takes on many essential forms, the body of Christ is most often associated with the outreach and caring of the local congregation.

This book celebrates the importance of the local church. It is based on two convictions. First, congregations yield unanticipated riches when taken as worthy objects of serious study. Second, the accumulation of several disciplines is necessary to fathom the diverse and complex interaction that characterizes the local church.

For many people, the beauty of a fresh look at congregations provides its own reward. The congregation appears to have endless resources in its history and in the intricate relationships and diverse perspectives of those who are committed to it. The congregation is always more than we expect because it has roots and resources beyond our understanding. The congregation is a complex gift of God.

Reflecting the fact that pastors and lay leaders alike have found the study of the congregation to be both challenging and fun, this book is written around a case study. In Part I the "case" of Wiltshire Church is presented. It is a factual account of a particular moment in the life of an actual church, although the names and places have been changed. A leading figure in the congregation tells his story, and further information is provided in background materials. This is not a model of perfection, but a congregation typical of many others, with a memorable history, identifiable resources, uncertain leadership, and recognizable problems. Given this base of information, you are invited to join with others in exploring the problems and possibilities for the people of Wiltshire Church.

The rest of the book is an exploration of insights based on studies of the Wiltshire Church case by authors who have had extensive experience working with congregations. Nine selected approaches are divided between two sections, Parts II and III, reflecting the distinction between those who seek to apply a particular discipline and those who focus primarily on the resolution of congregational problems. Part II consists of chapters written from the vantage point of disciplines that bring a recognized theoretical orientation to the study of congregations: psychology, anthropology, sociology, literary symbolism, and theology. These apblocks the building provide proaches multidisciplinary studies are constructed. Part III includes contributions from church-related consultants who employ several disciplines in working with congregations. They emphasize the necessity for a pragmatic and eclectic approach to respond to whatever problems and needs they find.

Part IV presents three efforts to assimilate the various approaches: first, through the practice of ministry; second, through the rubrics of practical theology; and finally, through contributions that congregational studies might make to the issues of contemporary church life.

The purpose of this book is to provide new routes into the social and spiritual dynamics of the local church. Renewed appreciation for the congregation should release new energy among the membership to challenge and enliven the whole Body of Christ. Here we see hope for clergy and church members working together to build more effective ministry in and through our congregations.

The labor and vision of many people are invested here. It is one expression of a continuing study of different approaches to working with congregations that has been under the direction of a Committee for Congregational Studies composed of Jackson W. Carroll, James F. Hopewell, Loren B. Mead, Barbara G. Wheeler, and myself. We especially appreciate the catalytic participation of Robert W. Lynn of Lilly Endowment and the support that made possible several interdisciplinary gatherings during the two years of preparation. We recognize with appreciation the extensive and creative work of the contributors who prepared and tested several drafts of each chapter in dialogue with representatives of several approaches. We received particularly valuable insights from more than three hundred pastors, executives, consultants, and other church leaders who met for a three-day conference in Atlanta, Georgia, reviewing the content of this volume and helping to shape it for publication. Several other people made extensive contributions, especially Elizabeth Whipple of the Rollins Center for Church Ministries, and Sue Cossey Armendariz, who served as research assistant and typist for the final draft. At the center of our work we want to thank the people of "Wiltshire Church," and the thousands of congregations like it, who have shared their lives in a way that all of us may learn to be more effective servants of our Lord.
